



## **Carney Roundup Rodeo Reality Ride Barrel Racing June 4 & 5, 2011 Held at the Nadeau Township Hall, US41, Carney, MI.**

This is the chance for male or female barrel racers ages 12-18 to run barrels in an official rodeo. There are 12 slots open each day (6 in each rodeo performance). The performances will be on Sat. June 4, 2011 at 5:00PM Central and Sun. June 5, 2011 1:00PM Central.

### **Rules**

1. Can be male or female
2. Must have at least one year experience riding horses.
3. Must have not ridden professionally in a rodeo.
4. Must furnish own horse with a negative coggins test.
5. Must fill out rider application and pre pay entry fee of \$25.00.
6. All horses must be trained to tie.
7. Each competitor can only enter one horse and said horse cannot be shared by competitors.
8. Unnecessary roughness or abuse will not be permitted and shall be cause for forfeiture of competitors entry fee.
9. Stallions can only be shown by 18 year olds.
10. Western attire is to worn in all events, (This will be enforced) anyone under the age of 18 is highly recommended to wear a helmet.
11. Pre-registration paper work has to be filled out and returned before May 20, 2011 with the \$25.00 entry fee and copy of a negative coggins test.
12. Remember we are only registering 12 riders. The ones that return the entry forms fist will have first chance, all others will be returned.
13. They will be asked to carry a flag in the grand entry on the day of their performance.
14. 2011 Reality ride Participant check List: 1. Approved Helmet if under 18  
2. Long sleeve Shirt (Western & Buttoned to the top) 3. Full length pants and belt  
4. Cowboy boots (Riding boots with heel) 5. Breast collar & Throat latch 6. Continuous reins 7. Negative coggins test. Note: You will not be allowed to ride if not wearing the proper western attire!
