CONCESSION INFORMATION

We require \$50.00 for up to 20 feet of outdoor frontage, and \$100.00 for indoor space. There will also be 10% of gross concession sales required and 30% of gross amusement sales required. [Amusement] Dunk Tanks, Air Slides, Mechanical Bull, etc. Balance due on sales within 30 days of Rodeo completion. For more information contact Bill Tebo IV 906-250-8212 prior to sending contract and space fees. At this time all Food Vending spots are full.

ALL VENDORS- will be required to operate and maintain Booths from 9:00a.m. to 8:00 p.m. Saturday June 4<sup>th</sup> and from 1:00 p.m. to 5:00 p.m. June 5<sup>TH</sup>.

Vendors are welcome to open Sunday morning due to activities on the grounds, (Cowboy church and breakfast ) but not mandatory until 1:00 p.m. Set up June 3<sup>th</sup> is encouraged but not required, but no later than 8:00 a.m. June 4<sup>th</sup>.

GENERAL LIABILITY- will be required to be on file prior to any set up, with a \$300,000.00 minimum. Vendors and Exhibitors agree to not hold Carney Roundup Rodeo, representatives of the rodeo, or co-sponsoring organizations responsible for property damage or loss, personal injury, or death occurring while being part of Carney Roundup Rodeo. Exhibitor agrees to assume liability for property damage, personal injury or death occurring within or outside the exhibit space from causes which originate within the exhibit space. This event is governed by the Michigan Equine Liability Act. Please send a copy of Insurance with rental space fees or set up will not be allowed.

REFUNDS- cancellations prior to May1<sup>th</sup> will receive full amount, after May1<sup>th</sup> will receive credit for next years Rodeo.

SECURITY- We strongly suggest you take adequate steps to avoid theft or damage to your property. There will be a night watchman on the Rodeo grounds, but will not be responsible for property and merchandise of exhibitors and concessionaries.

Two complimentary weekend passes will be included for each Vendor or Exhibitor space. Pets are not allowed on the Rodeo grounds except on a leash in the campground area only, which is outside the fenced area and entrance gates. Rustic camping is available for \$20.00(for the weekend), you must call to reserve due to limited space. 906-250-8212.
